Within the framework of the Improvement Program of Justice Administration System– PMSAJ, last January 20 was held the first virtual meeting of interoperability of the Non-Criminal Justice Adminsitration Systems

,which had the presence of the five representatives of the participant institutions of the program (PJ, AMAG, MINJUS, TC and JNJ) which purpose was the exposure of the work agenda called: "TIC: Technological Modernization".

Presentation in charge of our Executive Director Econ. Rodolfo Albán Guevara.

The presentation was in charge of our Executive Director, Econ. Rodolfo Albán Guevara, who stated that this (that of technological modernization) is a space that is to be institutionalized within the framework of the execution of the Program that has been carried out with funds from the World Bank with counterpart from the Peruvian State. He also emphasized the importance of the Program since what is intended is to improve the services of the administration of justice in order to guarantee the transparency, predictability and timeliness of jurisdictional decisions at the national level.

In this sense, this first day of interoperability was an effort made in order to open up dialogue and maintain an active space for communication at a technical level that allows the necessary coordination between the institutions that are part of the Program. , so that the proposed topics are approached and developed in their different dimensions in order to achieve the objectives set.



Interoperability constitutes an integrating factor between entities that is not exhausted in the exchange of information. Furthermore, it is an interaction tool in the achievement of mutually beneficial objectives for the entities of the SAJ, the same ones that can be predefined by them. In other words, interoperability can also be everything that the SAJ entities set as their objective, based on the information they handle.

EJE NO PENAL EXPEDIENTE JUDICIAL ELECTRÓNICO

For its part, in the presentation made by the Coordinator of the PMSAJ. Dr. Oscar Zapata, the main objective was to know the opportunities for technological improvement of the justice executing entities for the implementation of the Electronic Judicial File (EJE) by promoting interoperability among the entities that are part of the Program. Along with this, he unveiled four of the fundamental values that drive the project: the economy, accessibility, legality and legitimacy. These constitute a great challenge at the moment, although, nevertheless, with the support and use of information technologies, prompt, secure, reliable and essentially predictable justice will be facilitated, which implies one of the most important aspects in the development and modernization of the State. In that sense, the thematic developed

it was limited to the seven points contained in the work agenda. The first of these lies in knowing the information needs of each of the Justice executing entities and defining the informational interrelation between them. The second is the fundamental need to standardize the unique codes for human resources files and files, in order to be used by the entities in a more integrated manner. A third aspect refers to the definition of human talent training schemes that are related to the digitization of documents. The fourth point includes the identification of opportunities for improvement in the information systems (software and hardware) of each of the institutions. The fifth point consists of the discussion and definition of the best interoperability option to implement. The sixth point resides in the unification of domains, while in the seventh it was proposed to develop a questionnaire to redefine the needs of users

DIALOGUE OPENING:

In the different interventions, the participants representing the institutions that are members of the Program agreed that this meeting constitutes a first approach to share experiences fro their respective institutions, given that they have been having a kind of practical experience that It shows that interoperability advances are already taking place, spaces that are allowing a fluid dialogue to be maintained in such a way that the information needs of each of the institutions can be identified. The Program constitutes a magnificent opportunity to make interoperability effective in order to improve the country's Justice System.Dr. Cesar Rodríguez, from the Constitutional Court, stressed that it is really important that, being autonomous entities, they work in an articulated manner, in order to modernize the justice system. In 2020, despite the global tragedy that is being experienced, the TC has managed to digitize all its processes; and it has resolved 94% of the 6,000 files that it had planned to resolve, an achievement in a singular year. Now with the presence of the Program, it is possible to work in an articulated manner and it is an opportunity that should be taken advantage of. It is essential that the Constitutional Court can interact with the Judicial Power, since 99% of the cases resolved by the TC come from the PJ; In other words, the PJ is its main taxpayer of the procedural burden. be committed to digital processes interacting with the entities that participate in the administration of justice.

Gonzalo Zapata, from the Judicial Branch, also stated that they have made progress in digital transformation and integration as a result of the Pandemic, and the processes have been accommodated to the digital age: - there is an electronic table of parts; - The databases have been reduced, which used to be 160, now there are 86 and - The goal is to have a single database per Court in 6 months, to provide the information requested by the other entities; then it is sought to have a single database but this will be in a longer time.

María Vásquez stated that the MINJUS is also initiating several projects to improve its processes and procedures for digital transformation, highlighted the importance of the initiative so that entities are integrated and can interact to support themselves in technology issues, and thus be able to achieve the objectives to be achieved.

The representative of the Academy of the Judiciary, Ing. Hugo Ramírez Veliz, highlighted that AMAG in 2020 has started, as a result of the Pandemic, the process of digital transformation. He stated that currently all officials and workers in general use digital certificates for signing the documentation generated in all areas; Likewise, this digital transformation has allowed the activities of the three Academic Programs PCA, PROFA and PAP, to be

carried out without major inconvenience; The classes have been developed normally on the virtual platforms culminating in the execution of the 22nd PCA Program, and the courses and workshops of the 2020 Academic Plan. The admission exam to the 24th Magistrate Aspiring Training Program has been carried out , and this year it will continue with - a second virtual exam for admission to the 25th Program.

Finally, the proposals for the application of interoperability were explained, the same ones that are on the agenda, as is the case of the Executing Unit PMSAJ that is working intensively with the National Board of Justice that already achieved the viability of its project and that it is in the phase of preparation of technical files and, in the same way, with the Constitutional Court in a first approximation of the diagnosis of technological infrastructure in matters of processes for the elaboration of a new integrated file management system.

These advances show us that there is an effective will, not only political but also institutional, with the appropriate leadership of each of the institutions involved. Thus, through the interoperability of electronic government systems, it has been possible to take that great leap in quality in the management of information for the integration of the Justice Administration System and compliance with the objectives of the Program.
